7.2 Summery Update

Marske Hall and Sawmill Planning application of 2019 to convert the halls 10 apartments to 20 aparthotel units with events venue in basement and Sawmill to events venue was rejected in 2021. An appeal was made to the Home Secretary in 2022 and the three day hearing for this appeal was in October.

Day 1 was attended by residents and the Chairman of the Parish Council in the National Trusts offices in Bainbridge. After introductions anyone who had a statement to read out in consideration of the hearing was allowed to do so. Then the Inspector went through the Agenda for the day, listening to explanations and asking questions. Members of the public who attended were also allowed to ask questions or put points of view through out.

Day 2 concentrated on heritage matters and Day 3 involved a site visit by the Inspector

The decision will take 2 to 3 months to come through so there is nothing left to do. The Parish Council tried faithfully to follow the remit of material consideration and keep an open mind while not being influenced by personal feelings, Twitter and YouTube or outside points of view, impartiality is required and concentrating on what is in the plans and factual information. The individual must be taken out of the process otherwise there could be accusations of bias and the credibility of the Council is lost.

Now it is time to move on and the business of the parish council, whether it be drains or highways issues, to continue, that is the day to day work of a Parish Council.
