1	Apologies – Raymond Ridley received on the night due to internet issues Cllr Yvonne Peacock Pam Braithwaite Lynne Wallis	Action
2	Confirm minutes of the last meeting – Minutes of the meeting held on the 4 th February 2021 had been distributed and checked to be correct. No amendments were received. Cllr Coates proposed and Cllr Wallis seconded that the minutes were a true and correct record. Cllr Phillips signed the minutes.	
3.	Matters arising from previous minutes – <ul style="list-style-type: none"> Ornate tree guard to be purchased for Wild Cherry Gem in the village – The guard is in position and the invoice of £180.00 paid Repair to public footpath, steps & gate near Pillimire Bridge – Public Rights of Way contacted and a maintenance ref for the repair to steps given Ref 20.43/15/1. Follow up required on progress and clarification of responsibilities. Pillimire Bridge also requires attention and a hinge is broken/missing from the footpath gate further along. Public Rights of Way to be informed. Parish Clerk vacancy – Chair explained the process required to employ a clerk and the potential increase in residents precept to cover this. A Pro-forma letter to be sent to every household with more details. Cllr Wallis proposed Cllr Jarvis seconded. Increase to the Conservation Area – Cllr Phillips thanked Mrs S Villiers & Mrs N Meredith for their extensive work in obtaining information. The PC to contact National Parks to review the conservation area and options to extend and the impact this may have on other properties within the village. This would then lead to public consultation. Landslip near Packhorse Bridge – has been reported. As the footpath is remote and deemed to have little use no further action. A gate on the bridleway onto the Musgrove and Cleaburn pasture, grid ref NZ08427 00281 is very difficult to open as the gate has dropped, impossible on horseback and very difficult otherwise to open.
