MINUTES OF A MEETING HELD ST EDMUNDS CHURCH ON Thursday 3rd February 2022

- 1. Apologise for absence and reasons approved for absence. – Councillor R .Ridley**
- 2. Introduction** – The meeting started at 7 pm with a welcome to everyone and thanks to Ruth Tindale and Jennifer Williamson.
- 3. Declarations of interest.**
None.
- 4. Minutes of the last meeting** – Minutes of the 8th June and 4th November Minutes were approved and signed by the Chairman. PC proposed EJ seconded.
- 5. Public session.** – Members of the Public attended, to hear item 6.5.1, Marske Hall.
- 6. Ongoing matters.**
 - 6.1. Public footpaths**
 - 6.1.1.** Pillmire Bridge still requires maintenance. Clerk contacted Paths at North Yorkshire County Council. **Ongoing.**
 - 6.1.2.** To note that entry of Green Lane, between Skelton and Helwith was listed in error. **Resolved.**
 - 6.2. Website updates**
 - 6.2.1.** The price of a new page added to the website for Historical information was discussed and supported with no objections. **Resolved.**
 - 6.3. Standing Tommy figures**
 - 6.3.1.** The quote received for the sign for the Tommy figures was thought too high. Clerk still waiting for another quote to arrive, and Councillors requested that she keep looking. **Ongoing.**
 - 6.4. Bushy Park.**
 - 6.4.1.** To note that the clerk has helped Highways narrow down the specific problem and it now waiting for what action is going to be taken.

6.5. Marske Stable Block, Sawmill and Marske Hall.

- 6.5.1.** The new plans submitted for Marske Hall were considered and were supported. However, a concern was raised as to the entrance and exit to the Hall asking that people only enter via Hard Stiles driveway and exit via the Cat Bank gated driveway. This is due to the very sharp, blind bend just before the Hard Stiles driveway, which could lead to accidents if it was used as an entrance and exit to the Hall.

7. New Planning applications to consider.

- 7.1.** Planning Application 21/00974/FULL for Coach House Cottage were considered and there were no issues they could see so the Councillors supported it.
- 7.2.** Planning Application 21/00975/LBC for Coach House Cottage was considered and the Councillors supported it.
- 7.3.** Planning application 21/01025/FULL for Skelton Farm were considered and as the location was behind an excellent screen of trees it would have very limited impact on the neighbours, building materials used in keeping with the location and the changed windows would fit in with those on the same elevation, the Councillors supported it.

- 7.5.** Planning application 21/01090/FULL for Chapel Cottage workshop, were considered, such as the size of the building for the location, roofing materials used with alternatives discussed, the Councilors supported it.

- 9.1.** Skelton Lane speed limit was considered and after advise from Highways it was decided that this would not be possible to proceed. **Resolved.**

The clerk was asked to put any information on the website to assist anyone thinking of running for Councillor, as new Councillors were always welcome. **Resolved.**
- 9.3.** British Telecom's plans to change analogue landlines to digital in 2025. All Councillors expressed concerns about these plans and the impracticality of it in such rural areas as this parish. They did not support this planned action. **Resolved.**
- 9.4.** The new price increases from Vision ICT for the website were considered and decided that the benefit the website provided as a source of information for the parish was worth the increases. **Resolved.**
