MINUTES OF A MEETING HELD ST EDMUNDS CHURCH ON Thursday 4th August 2022

1. Apologise for absence and reasons approved for absence

2. Introduction – The meeting started at 7 pm with a welcome to everyone.

3. Declarations of interest.

4. Minutes of the last meeting – There were no Minutes to confirm.

6. Ongoing matters.

6.1. Public footpaths

6.1.1. It was noted that the clerk had still not had an update from Paths (NYCC) about the landslip. The clerk has reviewed the information and re submitted forms for Pillmire Bridge and Packhorse Bridge, Telfit. **Ongoing.**

7. Bushy Park.

7.1.1. It was noted that an email had been received stating a works order hasd been prepared for patching and shaping up the carriageway,primarily concentrating on the steep section where the adverse camber exists. Some of this has been started. The Councillors asked the clerk to check if they had a date yet for the rest of the work as there were concerns about farmers having to drive stock trailers up Clapgate Bank due to the Bushy Park being closed, during sheep sales, which is mid to late September.

8. Marske Stable Block, Sawmill and Marske Hall.

8.1.1. The details of the hearing were considered alongside information that Councillor Meredith had found. This was that the hearing would now be three days long with the first day concentrating on Non Heritage issues and the other two on Heritage. It was also understood that there would be a site visit with Highways and Environment Agency attending, with an emphasis on the effect of noise on Scriddehurst. The Councillors felt this was too narrow a scope as noise travels through the whole village due to the geography of the landscape. They asked the clerk to contact Mark Williams

at the National Park planning and ask him if he could confirm and could he also provide more information. The Parish Council plan to attend and speak at the hearing.

It was decided to wait until the Land Registry had dealt with the SIM search and told them of their findings, before any further action was taken.
