2. **Minutes of the meeting held on 11th November 2016**

The minutes were read out. No amendments were received.

3. **Matters arising**

Defibrillator – the pads have been replaced by the Ambulance team. New ones will need to be purchased for next year. The Ambulance team are to be notified if the Defibrillator is used.

NP will enquire about additional training.

4. **Computer/Website**

PC outlined the details with regards to applying for a grant towards purchase of a Laptop, Printer/Scanner along with setting up a Parish website to comply with the Transparency code etc.

EJ had researched cost of establishing a website and this was outlined to the meeting.

It was agreed to proceed with the application for the above and PC will complete the application and send it to YLCA

Cllr Jarvis proposed and Cllr Phillips seconded.

5. **Highways**

- PC had received a reply from Highways – Downholme Bridge does not pose any safety concerns and is being monitored, Temporary Bypass – land purchase is complete and is now a public maintained highway, Cattle grids on Cordilleras road are privately owned and this matter is currently being progressed with Highways legal team and Barningham Estates.
- Jonathon Brunton advised the meeting that he had problems with 4x4 and motorbikes on Skelton Lane and the Green Lane from Skelton to Helwith. The Police had been involved and as a result are asking Highways to provide improved and clearer signage of the temporary closure. PC will write to Highways to support this and to ask what are the plans for the lane and what happens at the end of the temporary closure.

6. Planning Applications

- P C has received confirmation that the planning application at Manor House Farm has been passed. Details are available from PC.
- PC has received confirmation that the junction of Jingle Pot Farm/Jingle Pot Farm road has been passed. Details are available from PC.

7. Correspondence

- Superfast Broadband is planned for parts of the Parish by end of Summer 2017. Further detail awaited.
- Calculation of Council Tax Base from RDC – Details available from PC.
- Copying of planning applications – blanket permission for Councils in the Richmondshire area.
