5. **Highways**
 - PC will ask Highways to improve the signage on the gates and cattle grids on the Cordilleras road. N P thanked D M and P G for their guidance.
 - P C will request an update from Highways on the 'Temporary Bypass' between Downholme Bridge and Marske, repairs to the Green Lane from Skelton Lane to Helwith and repairs to Downholme Bridge.
 - P G advised the meeting that she had discussed the temporary traffic lights at the bridge in Marske with Highways.
6. **Planning Applications**
 - P C has received confirmation that the planning application at Cordilleras Farm has been passed.
 - PC has received notification of revised planning application at Stable Block, Marske. Details are available from PC.

7. **Correspondence**

- Request for Parish Precept submission from RDC. This was discussed at length and it was agreed to leave the precept at £650/year for 2017. Proposed by Mrs P Braithwaite and Seconded by Mrs B Harwood Mann.
- P C advised the meeting of correspondence received with regard to removal of payphones by BT. PC replied this should be deferred until improved mobile coverage provided.

 - E J advised that the pads on the defibrillator need to be changed and he will do this. New pads will have to be ordered.
 - P B asked about defibrillator training. EJ advised that this is available depending on numbers.
