**Repair to cattle grid at Long Green** - Damage to the cattle grid at Long Green has not been repaired. Highways have left this issue with Barningham Estates to resolve.

**Green Lane Skelton to Helwith** – Repair work has been completed by Highways and overall they have done a very good job.

An email is to be sent to Highways thanking them for the repairs and to suggest a Temporary Closure to be enforced during the winter months (Nov-April); this could prolong the life of any repairs.

**8 AOB**  
Cllr Phillips wished to pass on his condolences to Cllr John Blackie's family and to note his thanks for all the enthusiastic support Marske and New Forest Parish Council received from Cllr Blackie over the years.

The gate on the public highway down to Helwith Manor (which is also a footpath and bridleway) is in poor repair and needs attention. Highways and the landowner to be contacted JW

Reinstatement of the 'SLOW' sign on the road surface at Clapgate bridge. Temporary signs to be requested until a permanent sign can be actioned. JW

Due to the road closures from the recent flooding, an increase in traffic via Marske is to be expected. Highways to be contacted to cut back foliage at Catbank and over by the Pylons to improve visibility of on-coming traffic and optimise road width for passing. JW

Richmond District Council has performed an initial review into all Polling Stations. The aim of the review is to ensure:

1. That all electors have reasonable and practicable facilities for voting
2. That as far as is reasonable and practicable, polling places are accessible to all electors, including those who are disabled.

Results - Marske & New Forest parish has less than 200 electors and costs approx. £500 per election, this is thought to be inefficient use of resources. The proposal is to move the Polling Station to Reeth. Cllr Good has contacted both Marske and Marrick Parish Council asking if the two villages could use Marrick Village hall as alternative. Under the new proposals both villages would travel to Reeth.

Cllr Jarvis proposed that the parish use a Richmond Polling Station, as most people travel to Richmond for either shopping, work or schools etc. This option was agreed by all parish councillors. Query this option with Richmond District Council & Cllr Good.
